THEYEAR 2022 Price Electric Cooperative INREVIEW 2022

Reflecting upon the previous year is a thoughtprovoking process when sharing this annual recap. 2022 brought a number of intriguing developments to PEC in addition to work as usual. Your cooperative continues to extend in new directions to meet the needs of its members while still providing the service you have come to expect from us and we truly want to be "your energy solutions cooperative." I am happy to share some of the noteworthy moments from behind the scenes at PEC in the last year.

With the number of new services remaining high in 2022, we continue to experience some residual effects with a higher than normal inventory. This is due to supply-chain issues that remain relevant. We are seeing some slow improvement in this aspect, but long lead times on Your cooperative continues to extend in new directions to meet the needs of its members while still providing the service you have come to expect from us...

essential equipment are still a factor in timing when to order supplies so they are on site when they are needed for planned projects, new services, member needs, and storm restoration.

The Generac program was introduced in early summer last year, and the first generator was installed in June. We ended the 2022 season with 40 generators installed, and this year's schedule is ramping up to be a full one. I am pleased that PEC can offer this value-added service to our communities.

New projects often require extensive front-end work before they are implemented, and in 2022, we prepared for a couple of exciting projects that will be carried out in 2023: a new solar project and an electric vehicle directcurrent fast charger (DCFC) installation. You will see construction of the array this summer under One Energy's direction on PEC lines. This utility-scale solar project will assist PEC's Ogema substation and offset the cost of purchased power that PEC requires to serve our members. The DCFC project will be installed by PEC crews, and will be located at the Prentice Truck and Travel Center. Construction on both projects is expected to begin in early summer.

The seven cooperative principles are at the heart of what we do, and we look for every opportunity to embody those principles. Last year, Federated Youth Foundation (FYF) funds, which are capital credits that are donated or forfeited to the fund, were allocated to a wide variety of community initiatives. In this way, we are able to uphold the seventh principle, concern for community. I am pleased to share that PEC is able to support local communities and other nonprofit organizations due to the generosity of its members. In 2022, FYF dollars were distributed to Price Ice Youth Hockey, Northwoods Players, the Red Apple, and many other groups that are doing good work to support social initiatives that provide opportunity for everyone.

There isn't a year that goes by without a storm, or a few, that causes outages that affect many members. 2022 was no exception, and as usual, PEC employees showed up and got the work done to restore power as quickly and safely as possible. I appreciate the patience and gratitude the membership shows on those days, which I understand can be difficult. Don't forget to check PEC's website for outage maps and PEC's Facebook page for news, company updates, and energy efficiency tips.

PEC regularly conducts a cost-of-service study to evaluate rates and projected budgetary needs. The latest cost-of-service study is underway and results will determine the course of action that needs to be taken regarding rates. I expect that the data will reflect the need for some adjustment in the near future, so please watch for further information in future issues of *WEC News*.

I am grateful for you, our members, and the opportunities we have to serve you. 2023 is shaping up to be another remarkable year for PEC, and I am looking forward to all the ways we can work to your benefit.



PRICE ELECTRIC COOPERATIVE 2022 ANNUAL MEETING MINUTES

The Phillips High School Auditorium, Phillips, Wisconsin, was the meeting place for the 82nd annual meeting of the membership of Price Electric Cooperative on June 9, 2022. The meeting was called to order at 6:03 p.m. by Chair Randy Kunsch.

Director Matt Christianson led the membership in saying the Pledge of Allegiance.

Director Mark Nyberg gave the invocation.

Chairman Randy Kunsch declared a quorum with the registration of 90 members at the meeting.

Chairman Randy Kunsch welcomed the audience and introduced Price Electric President/CEO Jeffrey Olson, Price Electric Cooperative employees, and Attorney Jessica Shrestha.

The current Price Electric Board of Directors introduced themselves, and the sole candidate for the District 8 seat, W. Scott Haggard, introduced himself.

- Photos must be high resolution—at least 300 dpi and 8"x10".


Photo Contest Rules and Details:

Energy Efficiency Tip of the Month



The location of your thermostat can impact your HVAC system's ability to maintain an ideal indoor temperature. For maximum accuracy, thermostats should be placed in the center of the home, away from air vents, plumbing pipes and exterior doors. Avoid placing items like lamps and televisions near your thermostat, which can cause the HVAC to run longer than necessary. Avoid installing thermostats in rooms that tend to feel warmer or colder than the rest of the home. Do not place furniture in front of the thermostat, which can block air flow and result in inaccurate readings.
