WINTER PREPAREDNESS TEST FOR DUAL FUEL PARTICIPATING MEMBERS

he 2023 Winter Preparedness Test for Interruptible Heat (Dual Fuel) Accounts is scheduled for **Wednesday**, **November 15**. This load control test is performed in advance of the winter full load control season to ensure members' familiarity with the control times and to ensure that backup heating systems are functioning properly. Dual fuel heat will start being controlled at 6:55 a.m., with a gradual restoral beginning at 10:00 a.m., with all loads being restored by 11:00 a.m.

The winter load control season runs from

December through February. On full load control days, dual fuel heat will begin controlling at 6:55 a.m., with a gradual restoral starting at 9:55 a.m., and all loads being restored by 11:00 a.m.

If you are a dual fuel heat or load management participant, you can sign up to be notified when there is a load control event. Notifications can be by phone call, text message, or email. CAPITAL CREDITS:

A BENEFIT OF MEMBERSHIP

PEC is a cooperative, and one of the things that makes us different from an investor-owned utility is that PEC is not in business to make a profit. We exist to serve our members and we belong to the community we serve. On the November billing statement, from October's usage, some members will see a credit. The members receiving the credit purchased electricity from PEC in 1995. Capital credit retirements being returned to members this year is \$296,639.

What are capital credits?

Capital credits are a unique financial benefit of being a member of PEC. As you pay your monthly electric bills, PEC uses funds to grow, operate, and maintain a safe and reliable electrical system. Any money received over and above the cost of doing business is called margins. Your portion of the margins is then returned to you in the form of capital credits. They represent your ownership stake in the cooperative. Being a member of PEC means these credits go back to you, our members, instead of to a group of shareholders.

HOW DO CAPITAL CREDITS WORK?



PEC tracks how much electricity you use and how much money you pay for it throughout the year.



At the end of the year, PEC assesses the finances to see if there is excess revenue.



PEC allocates the excess revenue as capital credits to the members, based on how much electricity you used.



When financial conditon allows, the PEC board of directors will retire, or pay, the capital credits to you.



Who is eligible?

Your household may be eligible for the Wisconsin Home Energy Assistance Program (WHEAP) based on several factors. If your household gross income (before taxes and other deductions) is less than the amount shown on the chart below, you may be eligible. You can apply at your local WHEAP agency, online, or by phone.

What is the Wisconsin Home Energy Assistance Program and how does it work?

WHEAP assistance is a one-time payment during the heating season (October 1-May 15). The funding pays a portion of energy costs, but it is not intended to cover the entire energy costs of a residence. The amount of the energy assistance benefit depends on a variety of factors, including the household's size, income, and energy costs. In most cases, the energy assistance benefit is paid directly to the household's energy supplier.

What types of energy bills are eligible for assistance?

Homes heated with wood, propane, natural gas, electricity, or fuel oil can receive energy assistance. Your household may also be eligible to receive a payment for your non-heating electric costs through funding provided by Wisconsin's Public Benefits Program.

If you currently do not have heat or may be disconnected...

Crisis assistance may be available if you have no heat, have received a disconnect notice, or are nearly out of fuel and are unable to purchase more. WHEAP agencies provide a 24-hour crisis phone number to help with emergencies after business hours. Non-emergency assistance may include information on how to reduce energy costs, counseling on budgeting and money management, and payments to an energy provider.
