# BECOMING A PEC DIRECTOR?

- 1 REVIEW THE PEC BYLAWS

  Visit priceelectric.coop to review director qualifications in Article IV of the bylaws. Qualifications and bylaws are found in the About Us-->My Coop tab.
- Directors serve 3-year terms.
  This year Districts 4, 5, 6 are up for election. Refer to the district map to identify your district.
- GET ON THE BALLOT
  Connect with the cooperative
  to indicate interest in running
  and receive a candidate
  petition sheet.
- PROMOTE YOUR CAMPAIGN
  Reach out to members in your district and let them know you are running for the PEC board.
  You will need to gather at least 15 signatures from active members in your district.
- Directors are elected at the Annual Meeting on June 6, 2024.

# WHAT DOES A PEC DIRECTOR DO?

#### How do I know if I am eligible to be a PEC director?

- You are a primary resident of the district you would serve.
- You are an active PEC member.
- You are not employed by or have a financial interest in a competing enterprise or business selling electric energy or supplies to PEC.
- You are not employed by PEC.

#### What are the responsibilities?


- Make decisions in the best interests of PEC.
- Approve general policies, budgets, capital credit retirements, etc.
- Attend monthly board meetings at PEC and occasionally travel to attend other meetings and events.

## When does the board meet?

Typically, the board meets at 9 a.m. on the last Thursday of the month.

## Is there compensation?

Yes, directors are paid per diem for each meeting plus a travel adder and mileage.





### Keep in Mind Cooperative Principle #2

PEC is owned by its members and guided by directors elected from the membership. This is the cooperative difference!



## **DIRECTOR NOMINATION/PETITION PROCESS**

his year, board director seats are up for election in District 4 (Worcester), District 5 (Elk, Harmony, and Winter), and District 6 (Flambeau, Lake, Chippewa, Shanagolden). Individuals elected will serve three-year terms. The nomination petition process is as follows:

- 1) Candidates must first obtain an official nomination petition from PEC headquarters.
- 2) Candidates must obtain signatures of at least 15 members in the nominee's district.
- 3) Petitions must be returned to cooperative headquarters no less than 60 days before the annual meeting date. The deadline for nomination petitions is **Friday, April 5, 2024**.
- 4) Cooperative personnel will verify the member signatures and districts.
- 5) A list of nominees will be posted at cooperative

- headquarters no later than 25 days prior to the annual meeting date; this year, that date is **Friday**, **May 10, 2024**.
- 6) Candidates who have met the timeline and who have the appropriate number of valid signatures on the petition will be listed on the ballot of the annual meeting as prescribed in the cooperative bylaws.

Please review the duties, responsibilities, and qualification requirements found at www.PriceElectric.coop. No nominations will be taken from the floor at the annual meeting if there is at least one nominee by petition who is able and willing to serve as director. If, for any reason, no timely nomination was made by petition, or if at the time of the annual meeting, all persons nominated are unable or unwilling to serve, then nominations may be made from the floor by any member who is a resident of the district for which the nomination is available.

The 2024 annual meeting will be Thursday, June 6, at Phillips High School.

# 2024 Scholarships
