- The Applicant will comply with and be bound by the provisions of the Articles of Incorporation and Bylaws of the Cooperative, and such policies, rules and regulations as may from time to time be adopted by the Cooperative.
- The Applicant, by becoming a member, assumes no personal liability nor responsibility for any of the Cooperative's debts or liabilities, and it is expressly understood that under the bylaws, members' private property is exempt from execution for any such debts or liabilities.
- When application is for joint membership, the parties are jointly and severally bound by the terms of this application and agreement, as defined by the bylaws of this Cooperative. Acceptance into membership of any person who is married shall automatically be deemed an acceptance of his or her spouse as a joint member unless that person otherwise directs in writing. Each Applicant is allowed one membership only. One membership is entitled to one vote.
- The Applicant hereby grants to the Cooperative, without charge, the perpetual right and easement over land owned by the undersigned as may be reasonably necessary for its lines and those of its licensees, as the same may be used for the transmission of electricity, gas, other forms of energy, or communications signals of any kind. Prior to any new construction or service upgrade, and for all existing and future facilities necessary to serve the Applicant or other members, the Applicant hereby consents to the entry upon the Applicant's land by the Cooperative to maintain rights-of-ways, cut, trim or remove trees, utilize herbicide treatment, construct, reconstruct, rephase, operate, repair, maintain, relocate and replace thereon and under the surface thereof all appropriate poles, cable, wire, and other attachments, equipment, accessories, and appurtenances. Prior to receiving service or when requested by the Cooperative if service already exhibits, Applicant agrees to execute and deliver to the Cooperative a written and recordable easement agreement on the Cooperative's standard form and with standard terms as may be amended and updated from time to time. All lines, meters, and property entrances must be accessible to the Cooperative.
- The Cooperative is authorized to enter a subscription in the Applicant's name to the Wisconsin Energy Cooperative News to be paid for the Applicant by the Cooperative out of monthly deposits made by the Applicant and other members for electric service in the same manner as are other expenses of the Cooperative.
- The Applicant consents and agrees to pay such late charges, fees, and interest in such manner as the Board of Directors may specify on any past due accounts, and understands that member's debts to the Cooperative may be set off against any sums due member or member's successors from the Cooperative.

 The Applicant hereby grants to the Cooperative a security interest, as recognized under the Cooperative Bylaws, by the Board of Directors. The acceptance of the application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative, and the terms of that agreeme shall include all relevant provisions of the Cooperative's Articles of Incorporation, Bylaws and policies, rules and regulations adopted by its Board of Directo This agreement shall be binding on the Applicant, his/her heirs, successors, and assigns.
