The undersigned (hereinafter called the "Applicant") hereby applies for membership in and agrees to purchase electric energy from Price Electric Cooperative, Inc. (hereinafter called the "Cooperative"), upon the following terms and conditions:

- 1. The Applicant will, when electric energy becomes available, purchase from the Cooperative all electric energy purchased for use on the property described below and will pay therefore monthly or annually at rates to be determined from time to time by the Board of Directors, it being understood that all amounts paid by Applicant in excess of operating costs and expenses of the Cooperative properly chargeable against the furnishing of such electric energy are furnished as capital. The Applicant will pay a minimum monthly or annual bill established by the Board of Directors for the class of service regardless of the energy consumed.
- 2. The Applicant will cause his/her premises to be wired in accordance with Wisconsin State Electrical Code and wiring specifications required by the Cooperative.
- 3. Applicant states that to his/her knowledge said premises have been wired in accordance with the safety requirements of the Wisconsin State Electric Code and the wiring specifications of the Cooperative. If upon inspection, such wiring is not approved, the Applicant will make all necessary changes to conform with the above codes and requirements; and, if such changes are not made within the time specified by the Cooperative, electric service may be discontinued until such changes have been made and approved by an Inspector.
- 4. The Cooperative is released from any and all liability of every kind and nature for damage which may occur from defective wiring of said premises, from failure to inspect said wiring and, Applicant agrees to hold the Cooperative harmless from all and such liability from damages direct or indirect, due to discontinuance of service.
- 5. The Applicant will comply with and be bound by the provisions of the Articles of Incorporation and Bylaws of the Cooperative, and such policies, rules and regulations as may from time to time be adopted by the Cooperative.
- 6. The Applicant, by becoming a member, assumes no personal liability nor responsibility for any of the Cooperative's debts or liabilities, and it is expressly understood that under the bylaws, members' private property is exempt from execution for any such debts or liabilities.
- 7. When application is for joint membership, the parties are jointly and severally bound by the terms of this application and agreement, as defined by the bylaws of this Cooperative. Acceptance into membership of any person who is married shall automatically be deemed an acceptance of his or her spouse as a joint member unless that person otherwise directs in writing. Each Applicant is allowed one membership only. One membership is entitled to one vote.
- 8. The Applicant hereby grants to the Cooperative, without charge, the perpetual right and easement over land owned by the undersigned as may be reasonably necessary for its lines and those of its licensees, as the same may be used for the transmission of electricity, gas, other forms of energy, or communications signals of any kind. Prior to any new construction or service upgrade, and for all existing and future facilities necessary to serve the Applicant or other members, the Applicant hereby consents to the entry upon the Applicant's land by the Cooperative to maintain rights-of-ways, cut, trim or remove trees, utilize herbicide treatment, construct, reconstruct, rephase, operate, repair, maintain, relocate and replace thereon and under the surface thereof all appropriate poles, cable, wire, and other attachments, equipment, accessories, and appurtenances. Prior to receiving service or when requested by the Cooperative if service already exhibits, Applicant agrees to execute and deliver to the Cooperative a written and recordable easement agreement on the Cooperative's standard form and with standard terms as may be amended and updated from time to time. All lines, meters, and property entrances must be accessible to the Cooperative.
- 9. The Cooperative is authorized to enter a subscription in the Applicant's name to the Wisconsin Energy Cooperative News to be paid for the Applicant by the Cooperative out of monthly deposits made by the Applicant and other members for electric service in the same manner as are other expenses of the Cooperative.
- 10. The Applicant consents and agrees to pay such late charges, fees, and interest in such manner as the Board of Directors may specify on any past due accounts and understands that member's debts to the Cooperative may be set off against any sums due member or member's successors from the Cooperative.
- 11. The Applicant hereby grants to the Cooperative a security interest, as recognized under the Cooperative Bylaws, by the Board of Directors.
- 12. The acceptance of the application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative, and the terms of that agreement shall include all relevant provisions of the Cooperative's Articles of Incorporation, Bylaws and policies, rules and regulations adopted by its Board of Directors. This agreement shall be binding on the Applicant, his/her heirs, successors, and assigns.
